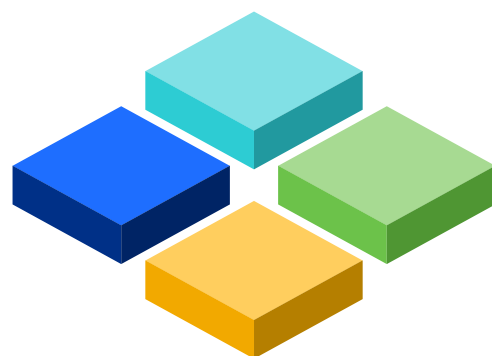

2018 eCQM Reports

eCQM reports for the 2018 performance year are available in addition to updated user reference materials. To access the new reports, go to **Reports > eCQMs > 2018**. Two reports offered in the 2017 performance year have been removed from the 2018 report list because they are no longer supported by the measure steward and are not eligible for MIPS or Medicaid Meaningful Use reporting:

- **CMS 126v5: Use of Appropriate Medications for Asthma**
- **CMS 163v5: Diabetes: Low Density Lipoprotein (LDL-C) Control (<100 mg/dL)**

CMS 166v7: Use of Imaging Studies for Low Back Pain is no longer eligible for MIPS reporting but can be used for Medicaid Meaningful Use reporting.

Patient Portal Flag Display on Active Charts

Patients enrolled in the patient portal can now be identified in the Active Charts section of the desktop. The purple patient portal indicator will display next to the patient name when the patient chart is added to the Active Charts list.

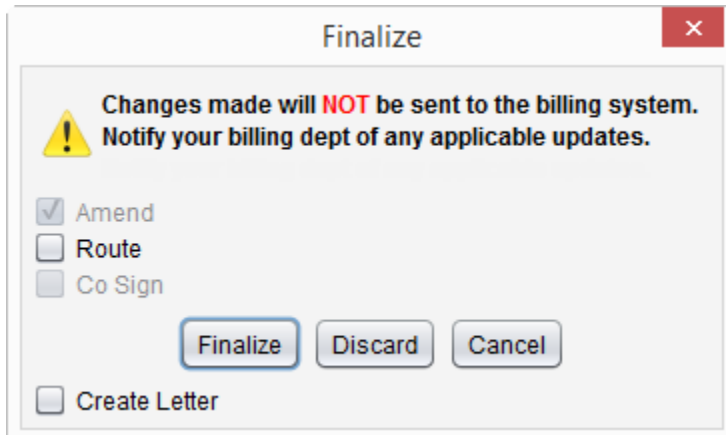
Charts already in the Active Charts list at the time of this feature deployment will not immediately display a portal indicator; the chart will need to be opened or removed and re-added to refresh the portal indicator setting.

Encounter Amendment Alert

Users finalizing an encounter amendment will be presented with a message on the Finalize dialog alerting them that changes made will not be transmitted to the billing system. This messages serves as a reminder to users to communicate any billing updates when amending an encounter.



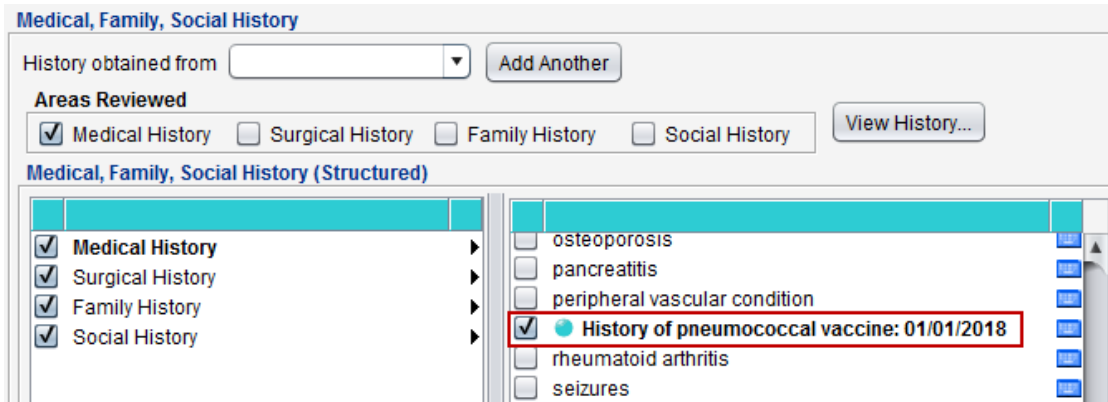
Warning on Finalize dialog for encounter amendment

New Past History Nodes

Hardcoded nodes have been added to the Past History Clinical Content for use in Medical and Social History. The **Pneumococcal vaccine** node is available for use in Medical History to document the previous receipt of a pneumococcal immunization.

Sexual Activity is available for use in Social History to document a patient's sexual activity. The functionality of this node is designed to replace the **Sexual History** hardcoded node.

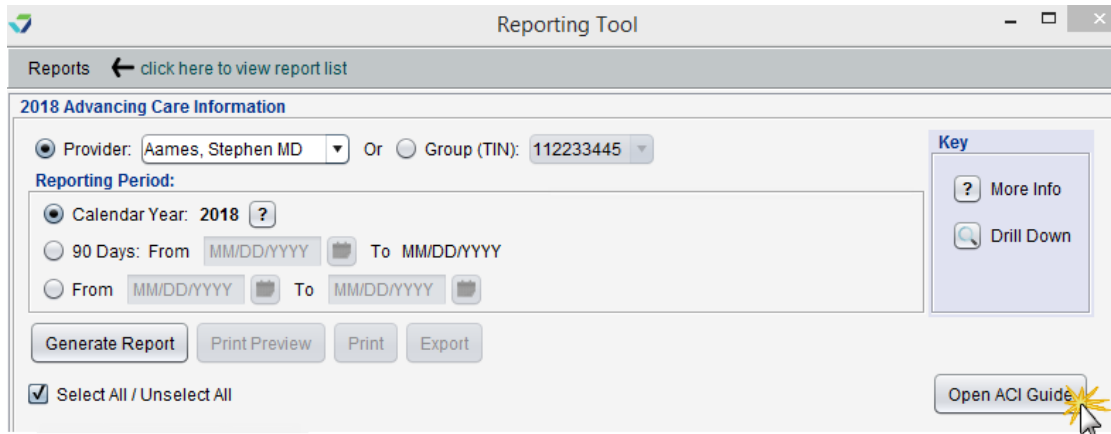
Customers with the Sexual History node in their Past History Clinical Content will continue to be able to use the content of this node; however Sexual History will no longer be available in the hardcoded node bank to add to Past History trees.
